Chair Report

It has been another busy quarter in Area 15. District chairs continue to do great work in carrying our message of hope in multiple locations and through multiple media outlets.

I am excited to report that we have added some new chairs who are enthusiastically jumping into the fray. Jo recently took over in District 1 and Paulette has awakened District 3. Thanks for your service as well as the continued great work from everyone else as well as their willingness to help out the new guys. I love our Team! Thank you Oscar for stepping up into the position of Alternate Chair!

Public Information: Districts continue to run informational ads in many local papers, on busses, in airports, and through PSAs on local TV and radio stations. Many of these ads are placed around holidays and other major events such as the Gasparilla Parade and several Pride events for additional exposure and to gain the most "bang for the buck". We are also using social media to spread the message including an entry into Fox streaming services.

Several districts have also embarked on public library projects to be sure our literature is available to anyone who might need it. We have focused on having the Big Book, 12/12, Came to Believe, and Living Sober in all of them as well as pamphlet displays where there is a community section available.

We continue to participate in lots of public events such as health fairs, community night out celebrations, pride events in Tampa as well as Venice, and even a county fair in St. Lucie. One of the events that we regularly attend has now partnered with the United Way so additional opportunities are coming from that including a new Salvation Army facility in North Port.

Cooperation with the Professional Community:

District chairs continue to be very active in working with schools to make presentations to students and staff. We have done presentations in numerous nursing schools, several behavioral health facilities, with police departments, sheriff departments, and in the court system especially the drug courts. We also work with the corrections committees to present to parole boards and corrections personnel as well as help those being released to get plugged in to AA on the outside through their parole officers as well as public information.

I recently attended the Live Tampa Bay Leadership Summit where the theme was on addictions and was able to make more contacts including a person who has written a play about his addiction entitled "The White Chip" which is currently playing in Sarasota.

- Pinellas County bus ad renewed for 2023/24— Our ad in running on one bus currently for 6 months in the north part of our county, then 6 months in the south part
- Our community newspaper ad renewed for 2023/24 is continuing to run through Pinellas County in rotating issues published by Tampa Bay Community Newspapers
- We have an upcoming speaking engagement at a health fair at St. Jeromes church in seminole on April 8th. We also set up an information table at their last wellness expo back in February with mild to moderate interaction.

- We have placed literature at 8 branches of Pinellas County libraries recently and have been restocking pamphlets.
- We have also just recently reached out to our local drug court program and DUI school to see if they would be interested in future commitments and have offered literature and pamphlets to both.

The months of January, February, and March were busy ones for our Committee.

Press: Our Creative Loafing Magazine Gasparilla PSA ran in the January 25th edition. The Committee continues its outreach to underserved communities with the purchase of five different two-week print and digital PSAs in the African American newspaper The Florida Sentinel for the remaining holidays of Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas, and New Year's. The Committee has also purchased two-week print and digital PSAs in the LGBT magazine Watermark issues of March 23rd for St. Patrick's Day and Tampa Pride, June 2024 for St. Pete Pride, and year-end December-January issues for Christmas and New Year's.

Schools and Professional Events: Suzanne presented to University of Tampa Nursing School students at St Joseph's Hospital's Behavioral Health facility on February 20th and 23rd. Suzanne attended the Hillsborough Recovery Coalition on March 18th as a representative of District 2's PI-CPC Committee

Public Information: Regarding our approved Special Project Motion to run the GSO-approved PSA entitled "My Drinking Built a Wall" using the Fox FLX streaming services across all their digital platforms: The PSA ran from December 24th through St Patrick's Day in March. We were able to see exactly how many different people saw the PSA. The PSA had 174,302 Impressions which means it was aired 174,302 times. It had 69,794 Unique Impressions which means it was seen by 69,794 different persons. The PSA had a Completion Rate of 98.6 which means 98.6% of viewers saw the entire PSA without shutting it off. These numbers all came above the initial estimates we had at the beginning of this campaign. The vast majority of views were on Tubi at 32.45%, followed by Pluto and Xumo combined at 18.71%, and Samsung TV Plus at 14.14%. The remaining views were scattered across websites, tablets, and desktops. Overall, the Committee is very satisfied with the results.

Libraries: All Hillsborough County Public Libraries are being restocked with the pamphlet "AA at a Glance" by Committee members as needed.

Chair Comments: I attended the Area15 PI-CPC in-between Conferences meetings over Zoom. I was assigned by District 2's Chairperson to present an overview of Public Information Conference Agenda Items "F", "K", and "N" to District 2's General Service Committee at the March 24th District meeting.

3. North Port Night Out

The Second Annual North Port Night Out was well attended. We made two contacts for future events. One with the Police Department Training Office and one for a Health Fair in April sponsored by the Kiwanis Club.

4. Today Matters Mental Health Services, New Life Church, Punta Gorda

The presentation by Florida Highway Patrol, Lt. Buenos Public Affairs was on Fentanyl Trafficking approached him after the presentation exchanged business cards and discussed future presentations to their training department.

5. Recovery DeSoto

I received a request for information from GSO from this organization. Met them for lunch to discuss their goals. I provided them with literature, books and structure for meetings. My

conclusion is that they are more focused on opiate abuse and suggested that they contact NA. They do have contacts within the Drug Court in DeSoto County, which is something we are working towards, however this project needs future work to be completed.

At the Old Timers Dinner, I met a couple who live in DeSoto and work with the Corrections Committee who are working with a local DA office. I will be coordinating with the Corrections Committee on a Zoom call on April 13 to further explore getting AA presentations into the

6. Sunlight Mission Health Fair February 23

DeSoto Drug Court in this part of District 5.

Focusing on financially at-risk individuals, this health fair provided health screenings, insurance and job training, and a variety of other services. It was smaller than last year and poorly attended. However, I made two great contacts for future events.

Area Agency on Aging Lois Kohler Social Worker interested in future presentations Alanon in Charlotte County Schools Gretchen Lepple

Gretchen is a former high school principal with experience navigating the politics of the school system. She has been successful in coordinating alateen programs in all three of Charlotte County High Schools. I will be following up in March.

7. Charlotte County Drug Court

One of our committee members found a great webpage on the CC Drug Court listing all the participating agencies. Letters of intent and interest were sent to each agency. I followed up with a phone call to the District Attorney's office and was directed to the gentleman responsible for coordinating the Drug Court activities. The agencies work together as a team and meet every Friday at 8:30 am before court starts at 9. He invited me to attend on Friday April 5 to learn more about how AA can participate in the Drug Courts.

The committee worked on a curriculum outline for the presentations we would provide to the Drug Court and came up with the following:

- 1. Preamble (read first using as a basic guideline for the presentation)
- 2. Information on Alcoholics Anonymous (White Sheet)
- 3. Meeting Lists
- 4. Difference in Open and Closed Meeting and Variety of Meeting Formats
- 5. Discuss Signing Card/Sheet (autonomy of each meeting)
- 6. What we Do and Don't do
- 7. How it Works
- 8. Mention Chair App
- 9. Mention Googling "AA Near Me" (Gives info on AA for a 50-mile radius)

8. Kiwanis Health Fair/Safety Matters Expo

We were invited to participate in this event in North Port based on a contact made at the North Port Night Out event. There will be a broad variety of social services including free mammograms for financially qualifying women. Since the event coincides with the Assembly, one of the members of my committee will man the booth for me. I will have more about the turnout in my next report.

9. Charlotte County Schools Alateen/Alanon

I met Gretchen at the Sunlight of the Spirit Health fair. I spent the better part of March building a relationship with her, having coffee, lunch and attending an Alanon meeting together. She is meeting with the School Board in Charlotte County on April 3 and will be discussing getting back in the H.O.P.E. classes in the future and bringing AA along as an additional speaker. She has given me great information on the politics involved in this, the format of the presentations, and best times of day to present to the kids. She has been a valuable resource to our committee as we didn't think it possible to get back into the schools here in Charlotte County. I will be following up with her about her meeting with the School Board the week of April 7.

10 **Old Timers Dinner**

We provided a table on PICPC at the dinner and through networking, met a couple who live in DeSoto County and are working with a local Districts Attorney's office to enhance the efforts of the Corrections Committee. I was introduced to the and we discussed how our efforts together might also lead us into the Drug Court in DeSoto County. As a result of this, I will be participating in a zoom call with the Corrections Committee on April 13 to further discuss this project.


February 2024
